1	BEN Open Action Items	This view returns information about the enrollment action items that are to be completed. This information is accessible through the Benefits Administration > Enrollment work area > Benefits Summary > Pending Actions. A record is returned for each combination of a person full name, a life event name, an action type name, a program name, a benefit plan type, a benefit plan name, and a benefit option name.
2	BEN Court Orders	This view returns information about the court orders for the enrolled dependents in the benefit plan. This information is accessible through the Enrollment work area > Benefits Summary > Court Orders. A record is returned for each combination of a person full name, an order identifier, a court order effective start date, a court order effective end date, a dependent name, a dependent order start date, and a dependent order end date.
3	BEN Bill Charge Details	This view returns the bill charge details of a person that are generated for a calendar period. This information is accessible through the Enrollment work area > Billing > Benefit Coverage Charges. A record is returned for each combination of a benefit group name, person full name, billing period, bill number, and bill

		charge detail identifier. The information returned by the view pertains to the year specified in the effective date. For example, if the effective date is 24-Nov-2018, the view provides the bill charge details created in 2018
4	BEN Covered Beneficiaries	This view returns information about the beneficiaries chosen by an employee. This information is accessible through the Enrollment work area > Benefits Summary > Enrollments > Beneficiaries. A record is returned for each combination of a benefit group name, person full name, program name, benefit plan type, benefit plan name, benefit option name, beneficiary full name, beneficiary relationship, and beneficiary address type.
5	BEN Covered Dependents	This view returns information about the dependents of employees and their covered benefits. This information is accessible through Enrollment work area > Benefits Summary > Enrollments and Benefits > Your Benefits. A record is returned for each combination of a person full name, program name, benefit plan type, benefit plan name, benefit option name, dependent full name, dependent relationship, and dependent address type.
6	BEN Life Events	The view returns information about the life events of persons. This information is accessible through the Enrollment work area >

		Benefits Summary. A record is returned for each combination of a benefit group name, person full name, benefit relationship name, life event name, life event status, person in life event identifier, and benefit relation effective start date.
7	BEN Participant Enrollment Disclaimers	This view returns information about the legal disclaimers of the program in which the participants have enrolled. This information is accessible through the Enrollment work area when a person enrolls or modifies an enrollment. A record is returned for each combination of a person full name, life event name, life event status, participant disclaimer status, and participant legal disclaimer identifier.
8	BEN Potential Life Events	This view returns information about the active potential life events of a participant. These life events either occur over a passage of time or are explicitly assigned scheduled events. This information is accessible through the Enrollment work area > Benefits Summary > Potential Life Events. A record is returned for each combination of a person full name, benefit relationship name, life event name, life event status, benefit group name, potential life event identifier, and benefit relation effective start date.
9	BEN Person Habits	This view returns information about the habits of an employee. This information is accessible through the Benefits Administration >

		Enrollment > Person Info. A record is returned for each combination of a legal employer name, a person full name, an effective start date, an effective end date, and a person habit identifier.
10	BEN Enrollment Results	This view returns information about the enrollments of an employee and a nonworker. This information is accessible through Benefits > Your Benefits and Enrollment and also through the Enrollment work area > Benefits Summary > Enrollments. A record is returned for each combination of a person full name, program name, benefit plan type, benefit plan name, benefit group name, and benefit option name.
11	BEN Enrollment Costs	This view returns information about employee enrollments and the associated cost. This information is accessible through the Enrollment work area > Benefits Summary > Enrollments and Benefits > Your Benefits. A record is returned for each combination of a person full name, a program name, a benefit plan type, a benefit plan name, a benefit option name, an activity type, an annual amount, a rate display type, a benefit group name, and an element entry value identifier.
12	BEN Bill Payment Details	This view returns information about the bill charge payments, which are generated for a calendar period for a person. This information is accessible through
